# In controversial ruling, state supreme court says gay marriage ban is unconstitutional

The Connecticut Supreme Court's ruling Friday that same-sex couples have the right to marry was both heralded as a "victory for human dignity" and condemned as an "undemocratic fiat."

"This victory for human dignity is a victory for all people who are discriminated against based on their sex, race, ethnicity, ability, gender expression or any other immutable God-given aspect of their being," said Frank O'Gorman, director of People of Faith CT.

"Today, one of the most marginalized and dehumanized groups in society is taking its rightful place at the marriage table. This ruling has been centuries in the making and many months in anticipation," O'Gorman said.

As of spring 2008, there were 1,855 same-sex couples living in civil unions in Connecticut. They make up about 20 percent of same-sex couples statewide, according to researchers at the Williams Institute at the UCLA School of Law.



The institute is dedicated to research on issues related to sexual orientation law and public policy and it is the only research center at a law school that focuses on lesbian, gay, bisexual and transgender matters.

The Catholic Bishops of Connecticut and the Connecticut Catholic Conference issued a statement saying they were "extremely disappointed" in the ruling, a decision they said goes beyond the parameters set by the legislature and "imposes" the recognition of same-sex marriage upon state residents.

"The Connecticut Supreme Court has not just extended a supposed civil right to a particular class of individuals, but has chosen to redefine the institution of marriage," the statement said. "The real battle in this court case was not about rights, since civil unions provide a vast number of legal rights to same-sex couples, but about conferring and enforcing social acceptance of a particular lifestyle; a lifestyle many people of faith and advocates of the natural law refuse to accept."

Michael Culhane, executive director of the Connecticut Catholic Conference, said Friday that the organization believes marriage is defined as a union between a man and a woman.

"The basic concern of the bishops is that this ruling goes against thousands of years of tradition as upholding the institution of marriage between a man and a woman," he said. "It goes against natural law."

State Attorney General Richard Blumenthal said that an appeal to the U.S. Supreme Court is not possible because the decision was solely an interpretation of state constitutional law.

"The state's highest court today (Friday) ruled that the Connecticut law limiting marriage to heterosexual couples violates the state constitutional guarantee of equal protection for all," he said. "The (court) determined that the law fails to meet state constitutional standards."

But Peter Wolfgang, president of the Family Institute of Connecticut, issued a statement saying the organization would seek other remedies, such as a constitutional ban on same-sex marriage.

"Connecticut does not want judges to impose same-sex marriage by undemocratic fiat," Wolfgang said.

Carolyn Kaas, associate professor of law and director of the Family Law Concentration at Quinnipiac University Law School in Hamden, said the court's decision can not be reversed by the legislature or any federal court. The only option for opponents of same-sex marriage to undo the Supreme Court's decision would be to have it disallowed under the state constitution.

"That's a high-risk proposition," Kaas said. "You can't just re-open a piece of the constitution. The whole thing would get re-opened."

She was a signatory on one of the amicus briefs filed in the case. The legislation enabling civil unions, she said, was a step forward but it left some legal problems unresolved, especially when it comes to questions of equality.

Kaas also noted that the historic ruling has a limited reach. The federal government does not have to recognize gay and lesbian couples living in Connecticut as married when it comes to federal income tax filing or in administering Social Security or pension benefits, for example. Also, Connecticut can not force other states to recognize the marriages.

"That's still not exactly equal," Kaas said. "No state by itself can change what the federal government has done."

State Sen. Michael Lawlor, chairman of the legislature's Judiciary Committee, said he expects the General Assembly will pass a gay marriage law next year codifying the Supreme Court ruling.

"It's important that both the legislature and the court weigh in," he said. "The court is saying that it's a constitutional requirement that marriage should be equally available to gays and straights and the legislature should weigh in saying whether or not it's constitutionally required, it's the right thing to do.

Kaas said she believes the entire country will eventually recognize same-sex marriage. "It's so fundamentally fair," she said.
